ARTICLES OF INCORPORATION  
OF A VIRGINIA NONSTOCK CORPORATION

MVHS Warrior Band Boosters Inc.

**ARTICLE I:** The name of the corporation is MVHS Warrior Band Boosters Inc

**ARTICLE II-A:** The specific purpose of this corporation is to support Magna Vista High School Marching and Concert Band Programs, raising funds, recruiting volunteers, and conducting events for the benefit of the band students.

**ARTICLE II-B:** The corporation shall have one or more classes of members with such designations, qualifications, and rights as set forth in the bylaws. The directors shall be elected by the members as set forth in the bylaws.

**ARTICLE III-A:** The corporation's initial registered office address, including the street and number, if any, which is identical to the business office of the initial registered agent, is:

**ARTICLE III-B:** The registered office is located in the  county OR  city of:

- ARTICLE VI-A:** The corporation is organized and will be operated exclusively for charitable and educational purposes within the meaning of 501(c)(3) of the Internal Revenue Code. (All references to sections in these Articles refer to the Internal Revenue Code of 1986 as amended or to comparable sections of subsequent internal revenue laws.) In pursuance of these purposes, it shall do all things necessary, proper, and consistent with maintaining tax exempt status under section 501(c)(3).
- ARTICLE VI-B:** No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.
- ARTICLE VII:** The property of this corporation is irrevocably dedicated to charitable and educational purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution or winding down of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable and educational purposes and which has established its tax exempt status under Internal Revenue Code section 501(c)(3).
